CSLC received a \$2.5 million SBA Community Navigator Pilot Project (CNPP) grant and 'hit the ground running' to serve!

The administration and staff of the Community Students Learning Center (CSLC) were humbled and elated to be awarded one of 51 Small Business Administration's (SBA) new Community Navigator Pilot Program (CNPP) grants in the amount of \$2.5M.

"Oh, we are extremely grateful for the opportunity to serve as one of the 51 grantees nationwide to help navigate, build, and connect small businesses to available and valuable SBA and other government resources," said CSLC Board President

Leslie Greer in an article about the announcement published in *The Mississippi Link*. The announcement was made late October 2021 by U.S. SBA Administrator Isabella Casillas Guzman. The CNPP will provide a total of \$100 million in funding to 51 organizations that will work with hundreds of local groups to connect America's entrepreneurs to government resources, so they can recover and thrive." Funding was awarded by SBA in three tiers (with level-specific descriptions): Tier 1, eight awards max \$5 million; Tier 2, 11 awards max \$2.5 million; and Tier 3, 32 awards max \$1 million. The CSLC, located in Lexington, Miss., was awarded at

the Tier 2 level. "I applaud the Biden-Harris Administration and my fellow congressional leaders for their visionary

foresight in establishing the Community Navigator Pilot Program (CNPP) initiative via the U.S. Small Business Administration (SBA) and Administrator Guzman," said U.S. Rep. Bennie Thompson.

CSLC's CNPP is called, Mississippi Opportunities for a Vital Economy (MOVE). Greer said CSLC, the CNPP Hub in Mississippi is humble to partner with North Central Planning Development District (NCPDD) and other Spokes. The CSLC CNPP hubs and spokes "hit the ground running" Dec. 1, 2021. They have already served more than 250 small business owners, helped them secure more than \$100,000 in SBA COVID-Targeted and Supplemental grants, and has hundreds of thousands pending in EIDL low-interest loans. Although the COVID-19 Pandemic heavily impacted the CSLC Teen Pregnancy Prevention Program (TPP) Health Optimization and Prevention Education (HOPE) project, its administrators, management, staff, community/core partners, including students, managed to pivot to a great success, Dec. 31, 2021! HOPE, using the Dibble Institute's evidenced-based curriculum, Love Notes, effectively impacted more than 1500 Holmes County Consolidated School District's (HCCSD) sixth through 12th-graders, across a 2.5-year period, on how to develop positive, safe, and healthy adolescent relationships. TIER, our evaluators, have completed their report, and it will be included in the end of project final progress report in March 2022. (See more HOPE highlights on page 2.)

The **U. S. Department of Justice** has awarded \$976,579 in Bureau of Justice Assistance (BJA) FY 21 Preventing School Violence: BJA's STOP School Violence Program funds to Community Students Learning Center (CSLC) located in Lexington, Mississippi. Community Students Learning Center will use funds to help reduce risk factors and increase protective factors to prevent school violence with training for local law enforcement officers, school staff, students, family, service providers, partners, and youth-serving professionals in Holmes County. - The CSLC SEEDS (Strategies for Emergency Empowerment for Delta Students) assisted the Life Help Therapist establish a calming room at Goodman Pickens Elementary for students with mental health and behavioral problems. SEEDS as of this writing, is also in the process of completing a very successful 18-month progress report for the SEEDS program to SAMSHA.
- CSLC SBA CNPP recruited and provided technical assistance to more than 250 small business owners make application for the COVID 19 EIDL loan and grant program. This EIDL program was administered by the SBA as part of the American Rescue Plan. The program ended 12/31/2021. CSLC, Knowledge Info LLC, and Fresh Start LLC serving as CNPP SPOKES helped business owners receive over \$100,000 in grants and well over \$150,000 in loans during the month of December 2021. CSLC CNPP Spoke Partner Martez Greer of Fresh Start Enterprise, LLC reports that he has gotten many appreciative comments from individuals who are grateful to learn about the SBA CNPP. "That was nice of you looking out for me and sharing this. I really thank you for that," Deacon Andrew Brown told him.
- WEM Consulting Group was among CSLC SBA CNPP Spokes that hit the ground running December 01, 2021. "The Community Navigator Pilot Program is blessing for anyone in business or desires to be in business," said Willie McGriggs, owner and consultant. FREE help with their business or business idea is already helping hundreds of people. WEM has designed a series of Business Training Presentations available to any/all Community Pilot Program Participants. "Brainstorming for A Better Business" is the subject title for this series.
